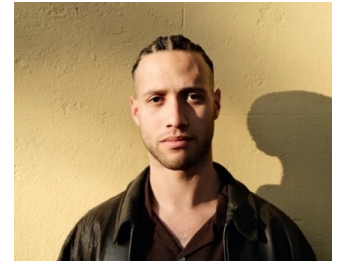

### Recent Project highlights:

- **Sound NSW Live Music Census (Sydney):** A first of its kind project for NSW, examining the live music industry's strengths, barriers, and opportunities to increase its social, economic and cultural impacts. I was the project's lead Social Strategy analyst, engaging in primary research activities and co-designing social analysis approaches. The project's key recommendations have shaped the NSW Government's Contemporary Music Strategy, which is delivering \$104 million of targeted investment into the sector between 2024-2034
- **Old Deptford Library Activity, Engagement and Interpretation Plan (London):** I was appointed on a freelance contract to deliver a Place Mapping and Audience Development Report for the Lewisham Arthouse, an artist collective who occupy the Old Deptford Library. I detailed local urban histories, demographics, cultural assets and community networks to support the Old Deptford Library renovation and programming uplift. My report helped guide the Lewisham Art House collective's vision for the refurbishment of the Old Deptford Library and its future community-focused uses.
- **Harborside Green Star Community Resilience Plan (Sydney):** I contributed to the development of a community resilience framework for Mirvac. I undertook a review of academic literature, international, state and local policies to inform the project's community resilience framework. This involved developing recommendations to shape development outcomes, contributing to Mirvac's achievement LEED certification in social sustainability for the Harborside Precinct.
- **Wesley Curtin MyHome Supported Housing (Canberra):** I served as Lead Social Analyst and Project Manager, delivering a comprehensive Theory of Change analysis demonstrating social benefits of supported mental health housing for tenants, the wider community, and the healthcare system. The research was used to support a federal government funding application for a new mental health housing scheme in Canberra (ACT). The funding application was successful.
- **City of Newcastle Affordable and Diverse Housing Investigation (Newcastle):** I collaborated with stakeholders across the NSW housing sector through workshops to build an understanding of key constraints and opportunities for affordable housing delivery in Newcastle. This informed Council's short- and long-term strategic planning frameworks to deliver diverse and affordable housing across the Local Government Area
- **Merri-bek Sports Surface Study and Decision-Making Framework (Melbourne):** I contributed to the design of a strategic framework to support Merri-bek Council to make decisions in the use and development of synthetic sports surfaces versus natural turf across their community assets. This was informed by in-depth research piece to support the framework's integrity under community scrutiny. We developed a tool kit to evaluate.
